### PREMIUM LEASE (NON-EXCLUSIVE LICENSE AGREEMENT)

THE WORK (AS DEFINED BELOW) IS PROVIDED UNDER THE TERMS OF THIS NON-EXCLUSIVE LICENSE AGREEMENT. THE WORK IS PROTECTED BY COPYRIGHT AND/OR OTHER APPLICABLE LAW. ANY USE OF THE WORK OTHER THAN AS AUTHORIZED UNDER THIS LICENSE IS PROHIBITED. BY EXERCISING ANY RIGHTS TO THE WORK PROVIDED HERE, YOU ACCEPT AND AGREE TO BE BOUND BY THE TERMS OF THIS LICENSE. THE LICENSOR GRANTS YOU THE RIGHTS CONTAINED HERE IN CONSIDERATION OF YOUR ACCEPTANCE OF SUCH TERMS AND CONDITIONS. PLEASE READ AND UNDERSTAND THE FOLLOWING CAREFULLY.

#### DEFINITIONS

1. **“Derivative Work”** means a work based upon the *Work* or upon the *Work* and other pre-existing works, such as a translation, musical arrangement, dramatization, fictionalization, motion picture version, sound recording, art reproduction, abridgment, condensation, or any other form in which the *Work* may be recast, transformed, or adapted, except that a work that constitutes a Collective Work will not be considered a Derivative Work for the purpose of this License.
2. **“Licensee”** a means an individual or entity exercising rights under this License who has not previously violated the terms of this License with respect to the *Work*, or who has received express permission from the *Licensor* to exercise rights under this License despite a previous violation.
3. **“Licensor”** means the individual or entity that offers the *Work* under the terms of this License.
4. **“Original Author”** means the individual or entity who created the *Work*.
5. **“Work”** means the copyrightable work of authorship offered under the terms of this License.

The following serves as a legally binding agreement between **Manwell Beats LLC** (hereinafter referred to as the "Licensor") and %MFS\_Client\_Name% (hereinafter referred to as the "Licensee"). This agreement, effective upon payment as of %MFS\_Order\_Date%, grants the Licensee **non-exclusive** rights to the song "%MFS\_Beat\_Name%" (hereinafter referred to as "Work"). The terms are the following:

### PAYMENT

(1) The Licensee must pay the Licensor a non-refundable license fee of sixty (\$60) U.S. Dollars for the non-exclusive use of the work being licensed in this agreement, for the purpose of using it for creating a new *Derivative Work* and using it for a film, video games, TV shows, or school project.

(2) If the Licensee fails to pay the Licensor, timely complete the payments provided for hereunder, or perform its other obligations hereunder, including having insufficient bank balance, the Licensor shall have the right to terminate this License upon written notice to the Licensee. Such termination shall render the recording, manufacture and/or distribution of the *Derivative Work* for which monies have not been paid subject to and actionable infringements under applicable law, including, without limitation, the United States Copyright Act, as amended.

### TERM

(3) This non-exclusive license agreement shall expire five (5) years from the effective date, %MFS\_Order\_Date%, of this agreement. Upon expiration, the Licensee will have to acquire another License or purchase an Exclusive License from the Licensor.

### MASTER RECORDING RIGHTS

(4) The Licensor hereby grants Licensee the non-exclusive right to record and synchronize vocals and instruments partly or in its entirety to the work to create one (1) *Derivative Work*.

(5) This license does not authorize use of the Work in any additional *derivative works*.

(6) The Licensee must obtain an additional license from Licensor for any additional *Derivative Works* using the Work.

(7) The Licensee shall not edit the Work in any way including, but not limited to, by changing the arrangement, removing or altering melodies, instruments, drum and rhythm programming, or sounds that are contained within the Work.

## OWNERSHIP RIGHTS

(8) The *Licensor* retains all rights in and to the *Work* including all rights in and to the underlying composition, and may continue to sell or license the *Work* non-exclusively and/or exclusively.

(9) The *Licensee* shall not sell or license the rights to the *Work* whether in whole or part to any other party.

(11) In the event *Licensor* sells exclusive rights to the *Work*, you shall retain your non-exclusive rights subject to the terms and limitations of this agreement.

## MECHANICAL RIGHTS

(12) The *Licensor* hereby grants to *Licensee* a non-exclusive License to use the *Derivative Work* in the reproduction, duplication, manufacture, and distribution of phonograph records, cassette tapes, compact disks, internet downloads, internet streaming platforms, and other and miscellaneous audio and digital recordings, and any lifts and versions thereof (collectively, "Recordings") worldwide for up to the pressing or selling a total of ten thousand (10,000) copies of such Recordings or any combination of such Recordings.

(13) Upon selling more than ten thousand (10,000) copies, the *Licensee* must acquire a new License; otherwise this contract along with its terms and rights are expired and the *Licensee* can no longer sell and/or distribute copies of the *Derivative Work*.

## PERFORMANCE RIGHTS

(14) The *Licensor* hereby grants to *Licensee* a non-exclusive License to use the *Derivative Work* in unlimited non-profit performances, shows, or concerts. The *Licensee* is also permitted to earn up to four thousand (\$4,000) U.S. Dollars in compensation or ticket sales using the *Derivative Work* in said performances.

## SYNCHRONIZATION RIGHTS

(15) The *Licensor* hereby grants to *Licensee* a non-exclusive License to copy, perform, edit and/or loop portions of, record on film, video, digital animations, and video games (collectively, "Projects") and use the *Derivative Work* in synchronization or timed relation with the productions in four (4) Projects.

## BROADCASTING RIGHTS

(16) The *Licensor* hereby grants to *Licensee* a non-exclusive license to broadcast or air the *Derivative Work* on four (4) radio stations or through four (4) station channels, respectively.

(17) *Licensee* agrees to exercise reasonable care to make such broadcast information available to *Licensor* so that *Licensor* can arrange to collect its performance fees.

## CREDIT

(18) *Licensee* shall acknowledge the original authorship of the *Work* appropriately and reasonably in all media and performance formats by acknowledging the relevant *Original Author* in writing where possible and vocally otherwise.

(19) The credit shall be substantially in the form: “Produced by Manwell”

(20) Where a project is commercially released and registered with a performance rights organization, the *Licensee* agrees to list and credit the *Licensor* for fifty (50%) percent of *Derivative Work’s* Writer’s share.

## SAMPLE CLEARANCES

(21) The *Licensee* is hereby notified that the *Work* may contain samples. The *Licensee* shall be responsible for clearing all samples. The *Licensor* shall not be liable for the use of any sampled material by the *Licensee* in any new composition.
